- I understand that all EWAL players who have not paid or turned in their USA hockey registration at the date required will be considered delinquent and is subject to being excluded from all EWAL activities and will be temporarily suspended from league play until all disputes are resolved.
- I understand that it is my sold responsibility to report any credit card changes that may effect my payments to the league treasurer immediately. I understand that any rejected checks and rejected credit cards are subject to a \$20 late fee as well as a \$20 processing fee.
- I understand that EWAL fees are NON REFUNDABLE/NON TRANSFERABLE. It is understood that if I/team choose to leave or quit the EWAL season for any reason, including but not limited to: Voluntarily declining to participate in games, leaving because of injury, playing at a higher level or dropping to a lower level, conflicts with game schedule, rink venue, or staff, ect, that I will be responsible for the entire amount of league dues for the full season.
